Kate specialises in all aspects of environmental law, including public international and European work.

She is experienced in public international law. Notable recent public international law cases in which she has been instructed as Counsel include: ICJ *Croatia v Serbia* (2014); ICJ *Australia v Japan* (“Antarctic Whaling” 2013); ICJ *Argentina v Uruguay* (2009).

She also has a particular expertise in international treaty negotiations, having worked as a legal advisor at the Department of Environment (International and EC Division) (1993-99) before joining Matrix.

Other recent work includes advising on the new EU common fisheries policy as it relates to fishing outside Union waters (including on the negotiation of sustainable fisheries partnership agreements with developing countries), advising the FAO on ongoing international negotiations relating to forestry, advising on the operation of EU legislation controlling trade in timber, advising Least Developed Countries and NGOs on the ongoing climate change negotiations and advising on EU legislation banning trade in seal skins. She has advised NGOs on the Arms Trade Treaty (ATT) negotiations. In 2006 and 2007 Kate was a member of two international Panels which reported on the legal issues relating to Japanese special permit whaling. She advises regularly on issues relating to animal welfare and trade.

Kate also has a practice in development-related work. Work in this area includes making a presentation to the European Parliament Committee on Development on legal issues relating to the negotiation of the Economic Partnership Agreements with ACP countries, advising on the human right to food and on supermarkets dealings with suppliers based in developing countries.

She practices generally in public law, particularly in cases with a public international, human rights or European Union element. Kate acted in the following leading public law cases: *The Countryside Alliance and others v HM Attorney General and Others* (the hunting ban); *Purja and others v Ministry of Defence* (public law discrimination case brought on behalf of Gurkha soldiers); and *Transport for London v London Underground* (public private partnerships, judicial review).

In 2014 Kate was appointed to the Attorney General's Public International Law Panel of Counsel (B Panel).

In 2015 Kate was appointed as Chair of the Legal Response Initiative, an organisation which provides pro bono support to Least Developed Countries and NGOs at the UNFCCC climate change negotiations.

## NOTABLE CASES

**ICJ Croatia v Serbia (2014)** The case was referred to the International Court of Justice by Croatia, who contended that the Federal Republic of Yugoslavia (FRY) had violated the Genocide Convention 1948 through activities undertaken against Croatian citizens between 1991 and 1995. James Crawford SC, Philippe Sands QC and Kate Cook, Helen Law, Blinne Ni Gralagh and Eddie Craven are acted for Croatia.

**ICJ Australia v Japan (Antarctic Whaling) (2013)** James Crawford, Philippe Sands QC and Kate Cook acted for the Australian government in proceedings instituted by Australia in the International Court of Justice in the Hague relating to a dispute concerning Japan's ongoing JARPA II program on "scientific whaling" in the Antarctic Ocean.

**Argentina v Uruguay (ICJ) (2009)** Philippe Sands QC and Kate Cook represented Argentina in this case concerning the environmental impact of pulp mills on the river Uruguay.

**The Countryside Alliance v Attorney General (2007)** Rabinder Singh QC and Kate Cook represented the RSPCA in a challenge brought by the Countryside Alliance and others to the Hunting Act 2004.

**Singapore Batam waste dispute (2005)** Kate Cook and Philippe Sands QC assisted the Government of the Republic of Singapore in resolving a dispute relating to a shipment of material from Singapore to Indonesia which took place last year.

**USA v European Union (2004)** Kate Cook was involved in the early stages of this case in which the United States brought the case in before the WTO Dispute Settlement Body in response to the European Union moratorium on the approval of GMOs.

**R (Purja & Ors) v Ministry of Defence (2003)** The case concerned the differential treatment afforded to Gurkha soldiers in the British Army in respect of eligibility for POW ex gratia treatment and same conditions of service and pension rights.

**R (Greenpeace) v DEFRA (2002)** Greenpeace contended that the import of Brazilian mahogany into the United Kingdom was unlawful because it constituted a breach of the regulatory regime of the European Union and because it contravened obligations in the Convention on Trade in Endangered Species of Wild Fauna and Flora 1973 (CITES).

**R (Transport for London) v London Underground Ltd (2001)** The case concerned the existence of an implied duty requiring LRT and LUL to act in accordance with the Mayor of London's transport strategy made pursuant to the Greater London Authority Act 1999.
